*Consumer Disclosure:* For prize, the odds of winning are based upon the number of entries received.

Registration will begin at 9 am on Wednesday, November 1<sup>st</sup> and run through Sunday, November 12, 2017. The winning names will be chosen at random and on Monday, November 13, 2017.

All entries must be received by Sunday, November 12, 2017. You may also drop off at our corporate office location at 3503 Peach Street, Erie, PA. Mechanically reproduced entries are not eligible. Proof of sending will not be deemed to be proof of receipt. Once submitted, entries become the sole property of Erie FCU and will not be acknowledged or returned.
